

## Privacy Policy

### *Introduction*

pckwikfix is sensitive to the confidentiality of your information and believes the protection of your privacy to be one of pckwikfix's significant responsibilities.

This Privacy Policy describes how and when we collect, use, and share your information across our websites, software system, SMS, email notifications, applications, product & service delivery, and that link to this Policy (collectively, the "Services"). For example, you send us information when you use our Services on the web. When using any of our Services you consent to the collection, transfer, storage, disclosure, and use of your information as described in this Privacy Policy. This includes any information you choose to provide that is deemed sensitive under applicable law.

When this policy mentions "we" or "us," it refers to the controller of your information under this policy. Your information is controlled by pckwikfix limited, 81 Lumloch Drive, Bishopbriggs, Glasgow, G64 1GT.

Irrespective of which country you live in, you authorise us to transfer, store and use your information in the United Kingdom, and any other country where we operate. In some of these countries, the privacy and data protection laws and rules regarding when government authorities may access data may vary from those in the country where you live.

Our services, both back office and front of house services may be hosted or provided from Data Centres throughout the world. Specific information on locations used is provided within our Data Security and Retention Policy documents.

### *Information Collection and Use*

*Basic Account Information:* If you choose to use pckwikfix to provide any products or services, you must provide us with some personal information, such as your name, email address, or phone number. In some circumstances if you are using some of our hosted services such as our hosted database products, this will mean we will be acting as the 'Data Processor' on behalf of the 'Data Controller' that is you, the hosted customer. Which will mean we have access to the information you store with us. This information is secure and is only accessed in a customer service role during an authorised and consented session with you or for service maintenance.

*Contact Information:* You may provide us with your contact information, such as your email address or phone number, to allow us to keep you updated the status of services we provide and, in some cases, to use as emergency contact information in a urgent or high priority situation. ## **The information you share with us**

We require certain information to provide our product and services to you. #### *Cookies*

Cookies are small pieces of information stored on your hard drive, not on the pckwikfix website(s). We do not use cookies to spy on you or otherwise invade your privacy. We use cookies to help you navigate the Websites and Services as easily as possible and to remember information about your current session. These are the Session Cookies and they are removed from your system when you close the web browser or turn off the computer. You must enable cookies on your web browser to use some of the Services. We use cookies to store content information and preferences.

Some cookies are essential for the basic functionalities offered by the Services. These class of cookies helps in keeping a user logged in to the Services and remember relevant information when they return to the Services. #### *Analytics*

pckwikfix uses third-party software for analytics. All metrics information collected from your usage of the Services shall be transmitted to analytics provider. This information is then used to evaluate how users use the websites, and to compile statistical reports on activity for us. We further use the same

statistical analytics tool to track or to collect your Personally Identifiable Information (PII). We will use this information to maintain, enhance, or add to the functionality of the Services and to personalise the experience for you. Anonymised and aggregated information and analysis may be made public where desired by us. Third party analytics software will not share your PII or associate your PII with any other data held by them. We use Google Analytics (Third Party).

## **How we use your information**

### *pckwikfix Employees and Privacy*

pckwikfix trains all employees about the importance of privacy. pckwikfix gives access to your information only to those employees who require it to perform their jobs.

### *Access by Our Employees*

Pckwikfix engineers and customer service agents have access to transaction information in order to respond to your questions. pckwikfix limits that access to the minimum information required in order to provide prompt, high-quality service. For example, these pckwikfix employees do not generally have access to complete credit card numbers.

Due to the nature of the activities carried out by pckwikfix, it is possible that we come across or require sensitive information such as passwords. Unless required for the activities in question and with your consent, these are not noted, used or stored. In occasions where this is required, passwords are located within a secure PAMS (Privileged Access Management System) operated by pckwikfix.

Full audit trail capabilities are utilised within this PAMS system to track employee activity with sensitive information. Multi-level access within PAMS such as user permissions is restricted to high level directors and senior engineers.

### *Privacy and pckwikfix partners*

When pckwikfix makes our products, technology or services available to business partners, pckwikfix will not share with them any more information than is necessary to perform the transaction you have requested. pckwikfix will make every reasonable effort to assure, by contract or otherwise, that these third parties use our information, technology and services in a manner that is consistent with this Privacy Policy.

### *Provision of Information to Others*

To perform the pckwikfix services, we must, of course, pass information about transactions to payment card processors and banks. From time to time pckwikfix may also provide third parties with aggregate information that is not linked to you or any other any particular individual. pckwikfix does not provide to any third party your name and e-mail address, or the names and e-mail addresses of other customers.

### *Corporate Data*

Protecting the privacy of a customer's personal information is a top priority; however, pckwikfix takes the protection of each customer's corporate data and confidentiality to be one of our most significant responsibilities. pckwikfix uses diligent efforts to ensure each customer's data integrity is limited to the company for which that customer works or has the authorisation to access by using a company-specific password, and that such company's data is not violated or accessed by unauthorised persons.

### *Information/Data Centre Security*

pckwikfix stores transaction information on secure computers located in a multiple secure and locked data centres. Where possible, pckwikfix encrypts information stored on pckwikfix computers as a further measure of protection. pckwikfix uses high industry standards in the acquisition and deployment of firewalls and other security technology to prevent pckwikfix computers from being accessed by unauthorised persons. pckwikfix makes access to confidentially sensitive information subject to rigorous procedural and technological controls, consistent with legal requirements and the demands of customer service.
